Trustee Redmond made a motion to accept the Gilbreath property split and was supported by Treasurer Passeno. The motion was carried by all. Trustee Fenlon made a motion to no longer have 14 days to sign and pay for renting the Community Center and was supported by Trustee Redmond. Supervisor Brandt voted yes, Trustee Redmond voted yes, and Trustee Fenlon voted yes. Treasurer Passeno and Clerk Neumann voted no on this motion. Benton Township will be recycling batteries for Benton Township residents. Commissioner Mike Newman stated that the McCLaren Mental hospital is open with 3 patients so far. Mike also stated that 911 system is still being worked on. Mrs. Ross stated that they are still looking into a solar generator for the Transfer station. Clerk Neumann read the bills to be paid in October. Trustee Redmond made a motion to pay the bills and was supported by Trustee Fenlon. The motion was carried by all.
